# June Quarter Distribution and Portfolio Pre-leasing Update

#### **Key Points:**

- June quarter distribution of US 0.76<sup>1</sup> cents per unit (AUD 1.16 cents per unit<sup>2</sup>), gross of US withholding tax
- Net cash distribution of US 0.65 cents per unit (AUD 0.99 cents per unit<sup>2</sup>) to be paid end of August
- The portfolio is now 88% pre-leased for the 23/24 academic year at rental increases of 8.5%
- 6 properties in the portfolio 100% pre-leased

#### June Quarter Distribution

US Student Housing REIT (ASX: USQ) ('USQ' or 'the REIT') is pleased to announce the June quarter distribution of US 0.76 cents per unit (AUD 1.16 per unit), gross of US withholding tax, and a net cash distribution of US 0.65 (AUD 0.99 cents per unit<sup>2</sup>).

#### **Pre-Leasing Update**

The portfolio is now 88% pre-leased for the 23/24 academic year at rental increases of 8.5% (prior year 8%) across the 9 assets owned by the REIT. 6 properties are pre-leased at 100% prior to moveins during mid-late August. We will provide further details to unitholders once leasing numbers are finalised at the end of August.

#### **New Academic Year**

The academic year in the Unites States commences during August and runs through to May/June of the following year. The month of August is a busy period for the Student Quarters (SQ or Asset Manager) onsite team with "turn" well underway due to new student arrivals ahead of the 23/24 academic year. As a result of typical costs associated with preparation of properties, the June quarter is the smallest quarterly distribution.
