US Student Housing REIT (ASX: USQ) – Results of Meeting (22 December 2023)

In accordance with ASX Listing Rule 3.13.2, Equity Trustees Limited and Auctus Asset Management Pty Ltd (**Auctus**) are pleased to announce the outcome of the resolutions put to the meeting of members of US Student Housing REIT (ASX: USQ) (the **Fund**) held today, 22 December 2023, pursuant to the Notice of Meeting and Explanatory Memorandum dated 30 November 2023.

The following resolutions were decided on a poll and were passed:

Resolution 1: A special resolution that, subject to Resolution 2, the Fund be removed from the Official List of the ASX under Listing Rule 17.11; and

Resolution 2: A special resolution that, subject to Resolution 1, the constitution of the Fund be amended to include an 'Exit Fee' on certain redemptions, and to provide that a unit must be redeemed within 545 days after a redemption request in respect of the unit is accepted.

Summaries of the poll voting results and proxy voting results for the resolutions are attached below.

Unitholders who intend to remain invested in the Fund after de-listing

Unitholders who intend to remain invested in the Fund after de-listing must complete a Transition Identification Form in order to ensure they can continue receiving quarterly income distributions, the ability to apply for new Units, or withdraw existing Units in the Fund after the Fund is de-listed.

The Transition Identification Form will be published on USQ's website (<u>https://usq-reit.com/</u>) over the coming days.

There may be different requirements for investors who have invested in the Fund via a platform. We suggest that those investors liaise with their platform for further information.

Unitholders who do not intend to remain invested in the Fund

Unitholders who do not wish to remain invested in the Fund can either:

<u>Sell their Units on the ASX</u> at the prevailing market price at any time before market close on **Monday**, **22 January 2024**.

Trading of Units in the Fund on the ASX will be suspended after market close on 22 January 2024 after which time you will not be able to sell your Units on market. The Fund will then be removed from the Official List of the ASX on Thursday, 25 January 2024.

Unitholders who wish to sell their Units on the ASX must do so before the Fund is suspended and removed from the Official List.

For the sale of Units **after Monday**, **22** January **2024**, unitholders must complete the Transition <u>Identification Form and withdraw their Units</u> in the Fund after the Fund is de-listed, pursuant to the process outlined in section 3.4 of the Explanatory Memorandum. We note that the first withdrawal cut-off date after de-listing will be 1 June 2025, and withdrawals after 22 January 2024 will be subject to the Exit Fee.

Unitholders must complete the Transition Identification Form in order to withdraw their Units in the Fund after the Fund is de-listed.
